## **Board of Commissioners**

Regular Meeting Minutes August 16, 2011

The meeting was called to order at 5:34 p.m.

The pledge of allegiance and prayer were given.

Roll Call: Chairman Kline and Commissioners Rich, Davis and Kingston were present. Commissioner Risley was absent.

### APPROVAL OF MINUTES-

Commissioner Davis made a motion to approve the minutes of the July19, 2011 meeting. Commissioner Rich seconded the motion. The motion carried unanimously.

Chief Hess swore in Firefighter Emmitt Hyde.

**b.)** The Massad Group- 2012 Health Insurance Renewal- Don Massad presented the grand recap for the insurance renewal, effective October 1. This presentation included the request for proposals process, historical rate reviews, annual renewal recap, medical loss ratio reports, insurance renewal quotes (BlueCross, Coventry, United Healthcare and Humana) and benefit enrollment guide.

Chief Hess reiterated the cost avoidance practices that the department has in place.

Mr. Massad explained that Humana has a Wellness program that is offered, at no cost.

**c.**) **Firefighter Frich-** Firefighter Frich thanked Chief Hess and the Board of Commissioners for allowing the members to speak out on issues involving their careers. Firefighter Frich read a letter

based on salary items that could potentially be reduced and the impact it will have on him, as well as the other members of the department.

- **d.**) **Fire Operator Morris-** Fire Operator Morris read a letter to the Board, essentially stating that the Board has chosen to operate at a millage that is lower than what the voters approved, therefore, resulting in budget cuts and potential salary reductions.
- e.) Fire Operator Willis- (not present)
- **f.**) **Union Representative-** Union President Chad Duffaut stated that times are hard and employees are living paycheck to paycheck and it doesn't appear that it will get any better. He asked the Board to please consider not making any cuts, to benefits and pay, and to absorb the cost increases (insurance and any other cuts being considered.)

Commissioner Kingston made a motion to accept the Chief's report. Commissioner Davis seconded the motion. The motion carried unanimously.

C) DiGiovanni & Associates, CPA's, L.L.C-

Mr. DiGiovanni discussed the financial report.

Mr. Waniewski explained the holdover/overtime pay concept. We are currently in the process of correctly allocating the overtime to reflect "Holdover pay" vs. "Overtime other". Mr. Waniewski stated that the addition of the \$36,000.00 to eliminate the "brownout" of Station 13 is currently not reflected in the budget, but will be added when the budget is revised.

Chief Hess discussed the excess spending in equipment maintenance repairs, stating that we have to get a handle on better formalizing our mechanical reliability program, as well as the issues leading to the failures that have to be fixed.

Commissioner Rich made a motion to accept the financial report. Commissioner Kingston seconded the motion. The motion carried unanimously.

**D) Attorney's Report-** Mr. Ingram reported, with respect to the CVS, a Resolution will need to be drafted to amend the previous Resolution 2010-007 for the surplus of the Brownswitch property.
