Board of Commissioners

Special Meeting Minutes September 26, 2013

The meeting was called to order at 6:06 p.m.

The pledge of allegiance and prayer were given

Roll Call: Chairman Crowley and Commissioners Kingston and McDonald were present. Commissioners Risley and Brackett were absent.

1.) To consider and take action with respect to announcing the date, time and location of a meeting to levy its ad valorem tax millage and parcel fee for 2013- Attorney Ingram reported that Grant Schlueter, Bond Attorney (Foley & Judell, L.L.P.), advised that this is the first year of a new millage, therefore, all procedures, with respect to roll forward, roll back, are inapplicable.

Attorney Ingram stated that an advertisement has been sent for a Special Meeting to be held on October 28, 2013.

There was discussion regarding the need for a budget workshop in order to be prepared to vote at the October 28 Special Meeting. Chief Kaufmann stated that with the budget process, that was completed internally, the break even millage would be 33.86 mills. The budget workshop is scheduled for October 12, at 9:00 a.m.
