Resolution of Board of Commissioners of St. Tammany Fire Protection District No. 1 Relating to the Approval of Intergovernmental Agreements by and between St. Tammany Fire Protection Districts, City of Covington Fire Department & District No. 1

WHEREAS, a quorum of the Board of Commissioners ("Board") of St. Tammany Fire Protection District No. 1 ("District") was present on this date for a properly advertised, regular meeting;

WHEREAS, the Board finds that it is in the best interest of the District, its employees, citizens and taxpayers to implement a program and procedure whereby the District has determined that it is in the best interest of the District to approve the intergovernmental agreements by and between St. Tammany Fire Protection Districts, City of Covington Fire Department and District No. 1 that authorizes the provision of District No. 1's communications center to dispatch emergency calls for each District / Department within said District's / Department territorial boundaries for a monthly service fee effective January 1, 2021 for a three (3) year period with a revision clause to adjust said agreement subject to a twenty-five (25%) percent increase in call volume for District No. 1;

NOW, THEREFORE, BE IT RESOLVED that:

1. The BOC wishes to approve the Intergovernmental Agreements by and between each District, City of Covington Fire Department & District No. 1 to dispatch emergency calls for said District's / Department territorial boundaries, effective January 1, 2021.
