Regular Meeting Minutes September 20, 2022

The meeting was called to order at 6:00 p.m.

The prayer and pledge of allegiance were done.

Roll Call: Chairman Crowley and Commissioners Rich and Powell were present. Commissioners Gay and McDowell were absent. (Commissioner McDowell joined via. phone)

APPROVAL OF MINUTES

Commissioner Rich made a motion to approve the minutes of the August 16, 2022 regular meeting. Commissioner Powell seconded the motion. The motion carried unanimously.

NEW BUSINESS:

- 1. Chief's Report
 - a) Significant Monthly Events
 - COVID-19 Update Chief Kaufmann stated that we have 2 employees out and one of them is on extended sick leave.
 - 2023 Budget- Chief Kaufmann thanked Commissioners Rich and McDowell for attending the budget workshop. A draft of the budget was presented and Chief Kaufmann requested that it be put on the October agenda to vote to advertise and a vote to adopt in November. Chief Kaufmann stated that the draft does include a slight salary increase and increase in the paramedic incentive. He further stated that the insurance benefit fund will cover the health insurance increase and there will be no changes to the employee paychecks.

 - 3 Resignations (Suppression)
 - St. 11 UPDATE Chief Kaufmann stated that construction is progressing with an early December projected completion timeframe. As previously mentioned, there have been delays with sub-contractors.

Chief Kaufmann recommended the two year, adjustable rate renewal, contract with Hancock Whitney.

Commissioner Rich made a motion to adopt Resolution 2022-040, Relating to the Approval of the By-Law Revisions for District No. 1. Commissioner Powell seconded the motion.

The floor was opened for public comment. There was no public comment.

Chairman Crowley stated that there were a couple questions that he felt the entire Board needed to be present to discuss.

Commissioner Powell made a motion to table Resolution 2022-040. Commissioner Rich seconded the motion. The motion carried unanimously.

- c.) **VFIS Special Risk Insurance & LWCC-** Mr. Waniewski stated that the LWCC renewal reduction was approx. \$117,000.

Commissioner Rich made a motion to accept the PMI report. Commissioner Powell seconded the motion. The motion carried unanimously.

4) **Duplantier Hrapman Hogan & Maher, LLP-** Mrs. Gaudin discussed the August financial report.

Commissioner Powell made a motion to approve the August financial report. Commissioner Rich seconded the motion. The motion carried unanimously.

5) Attorney's Report-

a) Legal Activity Report- Attorney Danenhower stated that he has not received anything from the Parish Council on the request regarding Commissioner Gay. He stated that he has sent a formal letter asking for an update, or to be placed on the agenda, to get this resolved.

Chief Kaufmann stated that Councilman Canulette has advised that it will be on the October agenda; however he is unsure if it is going to be a vote or public discussion.

Attorney Danenhower stated that there is still the issue on any action the Board would like to take regarding Mr. Ingram. He further stated that the concern is that it appears that Mr. Ingram was either self- serving and trying to preserve his position, or he was at least and/or facilitating Commissioner Gay to work against the best interest of the district. Mr. Danenhower stated that the evidence may even indicate that Mr. Ingram was linked with the attorney who sent the letter to the Parish Council; all of which would be a breach of duties.

Attorney Danenhower stated that anyone can file a complaint with the Bar Association and an investigation would be conducted. Chairman Crowley inquired as to whether the Board is interested in filing the complaint, or who should file the complaint. Commissioner Powell stated that the reason to file a complaint would be to ensure that something like this doesn't happen again. Chairman Crowley stated that he feels that as a

duty to the positions that the Board holds, and duty to the district and its employees, that there is a responsibility to report what is believed to have happened and it's up to the Bar Association to determine any wrongdoing.

Attorney Danenhower stated that he feels that something should be filed, whether it comes from the District, or elsewhere. He further stated that he feels CCST would file something; however, they may wait to see if the District does something. Chairman Crowley stated that he feels that if the Board doesn't do anything, there is a risk of losing integrity.

Chief Kaufmann stated that many lives were affected, and he feels Commissioner Gay was manipulated. Additionally, there was an attack on Commissioner Brackett. He further stated that at the special meeting, Commissioner Gay requested that a court reporter attend, and the testimony in the transcript is factual and Attorney Ingram notified Commissioner Gay of the letter, not the entire Board whom he was contracted to represent. Chief Kaufmann stated that his actions were blatant.

Attorney Danenhower stated that he feels that one of the critical concerns is if the Board has a duty to report this. Commissioner Powell stated that if an attorney is aware of wrongdoing, they have an obligation to report it. Attorney Danenhower suggested drafting a document to present the facts, that the Board is comfortable with, which will be sent to the Bar Association for them to make a determination.

Commissioner Powell made a motion to approve the Attorney report. Commissioner Rich seconded the motion. The motion carried unanimously.
